The Tent Suite price includes a covered space, an uncovered “patio” area in front of the tent, plus lighting, one (1) six foot rectangular table and a sign with your company name. You may order as many contiguous units of suites as necessary to accommodate your company’s needs.

Hospitality Terms & Conditions

Space for tent suites is limited and will be assigned on a first-come, first-served basis. A waiting list of requests will be maintained, if necessary. **Payment for hospitality spaces must be made by Tuesday, April 23, 2024. If payment for your hospitality space is not received by April 23, your company team's order and entry will be removed from the event.** You will have the opportunity to register during general company registration if space is still available. Otherwise, you will be able to join the wait list.

Adjustments to your original orders may be requested until Tuesday, April 23, 2024, and will be accommodated to the extent possible. In the event that you must cancel your picnic area or tent suite order, your payment (less a cancellation fee of \$100.00) will be refunded only if we can replace your reservation with a company from the waiting list. After Tuesday, April 23, 2024, all orders are final and may not be transferred, canceled, or refunded even in the case of event cancellation. In the event of postponement or cancellation of the event due to elements beyond our control, neither JPMorgan Chase nor any of its subcontractors or vendors will be held liable for any loss incurred.
